- 1. Passport: Current passport along with all expired/old passports.

 - Size: 50 mm × 50 mm (2 × 2 inches)
 - Head Size: 25 mm to 35 mm
 - For Children's Photos: Only the child should be visible in the photo
- 3. Employment or Business Documents
- 4. Financial Documents
 - Income Tax Returns (ITR)
 - ITR acknowledgements for the last 3 financial years
- 5. Identity Documents
 - PAN Card
 - Aadhaar Card

Application Process

1. USA – Visitor Visa – B1-B2
2. Step 1. Check Eligibility

3. ● B1 / B2.
4. ● B1 – Business meetings, conferences, negotiations, training.
5. ● B2 – Tourism, holidays, visiting family/friends, or medical treatment.
6. Step 2: Complete the DS-160 form
7. ● Fill out the online DS-160 Non-immigrant Visa Application.
8. ● Upload your passport-size photo.
9. ● Submit the form and print the DS-160 confirmation page with the barcode.
10. Step 3: Pay the Visa fee
11. ● Pay the non-refundable Visa application fee (currently US \$185 for a standard B1/B2 application).
12. Step 4: Create Visa Appointment Profile
13. ● Create an account on the U.S. Visa appointment website for your country.
14. ● Link your DS-160 confirmation number.

17. ○ Visa Interview at the U.S. Embassy or Consulate
18. Step 5: Prepare Your Documents

116. ● A government photo ID (such as Aadhaar or Driving License) as a backup, though it is generally not required if you have your passport.

118. What happens at the Biometrics Appointment?
119. ● Your passport and appointment details will be verified.
120. ● Your digital photograph will be taken.
121. ● Your fingerprints (all 10 fingers) will be scanned.
122. The process usually takes 10-20 minutes, depending on the number of applicants.

207. ● Approved: Your passport will be retained for visa stamping and returned to you by courier or collection, depending on the selected option.
208. ● Administrative Processing: Your application may require additional processing before a final decision.
209. ● Refused: The Consular Officer will explain the applicable section of U.S. immigration law under which the visa was refused.
