Application Process

1. USA B-1 Business Visa – Basic Application Steps
2. 1. Check eligibility for the B-1 Business Visa.
3. 2. Complete the DS-160 form online.
4. 3. Pay the visa application fee.
5. 4. Create a U.S. visa appointment profile.
6. 5. Schedule the visa interview/biometrics appointment, as applicable.
7. 6. Prepare all supporting documents.
8. 7. Attend the visa appointment/interview.
9. 8. Answer the consular officer's questions clearly and honestly.
10. 9. Wait for the visa decision and passport return.
11. Important: The applicant should not purchase non-refundable flight tickets before visa approval.
